



## **So you want to send your child to Panto Camp? Congratulations!!!!**

Panto Camp at The Laguna Playhouse is unique because our campers finish their week by **putting on a free Panto for their friends and family** (up to 3 guests per camper, and up to 4 if space permits)! Your child's never performed in a show before? No problem! All levels of experience are invited to participate, but they need to be between the ages of 8 and 13.

All campers will receive a limited edition Panto Camp T-shirt, and a gorgeous Panto Camp Certificate that's suitable for bedroom walls, or Mom or Dad's office. Our Panto Camp Staff consists of counselors who have performed in our Pantos over the years, and they'll be teaching improv technique, choreography, songs that your kids all ready know from hearing them on the radio, and then performing right alongside your children at the final presentation.

It's very important everyone realizes this is no ordinary Monday through Friday Summer Camp, as we'll have a final Dress Rehearsal and Performance on the Saturday of the session that your child attends. Just make sure your child is available for the Saturday final presentation, or please let us know in advance if they won't be able to attend.

Drop off each day will be at 8:45am in front of the Laguna Playhouse, 606 Laguna Canyon Road, Laguna Beach, CA. Panto Camp will be held in our air conditioned Green Room MainStage Rehearsal Hall. Lunch will always be from 12-12:45pm, so don't forget to send them with a nutritious packed lunch. At the end of each day pick-up will take place starting at 3pm. Rest assured that our Camp Counselors will be present at all times that campers are on our Playhouse campus.

OK, so WHAT HAPPENS at Panto Camp? On the next page is a breakdown of what the full week will look like. There will be improv classes, singing classes, dancing classes, rehearsals, a private backstage tour of The Laguna Playhouse, a headshot photo shoot so we have something we can put in the theatre's lobby for the Saturday presentation performance (you'll even have an opportunity to purchase this headshot, but purchasing is NOT required), your young performer(s) will get to walk the Red Carpet before their Saturday show, and the show will immediately be followed by a fun Opening Night after-party.

### **MONDAY:**

8:45am drop-off (today and all week)! After check-in, we begin each day of camp with morning announcements. On the first day, we take some time to get to know each student and get our acting juices flowing with some fun improv lessons. Don't forget to pack a lunch that we'll refrigerate for you, and bring a bottle of water. OK, lets eat (12-12:45pm). After lunch, we attend singing and dancing classes, then that's a wrap! You're ready to be picked up by your parent or guardian at 3pm (today and all week).

### **TUESDAY:**

Following check-in and morning announcements, we'll gear up for auditions with an audition prep class so we're fully prepared to showcase our talents at an 11am casting session. After lunch, the results from morning auditions will be announced and the cast list revealed. We get started right away with Act 1 rehearsals until it's time to go home.

### **WEDNESDAY:**

Costume fittings begin on our third day of camp, and you'll want to bring fun things from home to wear as well. We'll then continue with Act 1 rehearsals for the rest of the day. It's hustle time! While some campers are rehearsing today, other campers will get a private backstage tour of The Laguna Playhouse. See our backstage, the scene shop, the dressing rooms where actors hang out during our mainstage Playhouse productions. Don't be jealous parents! And don't worry, all campers will take the tour at some point during their week.

### **THURSDAY:**

Get ready for your close-up! On the fourth day of camp we'll take individual headshots of each cast member and get busy on Act 2 rehearsals.

### **FRIDAY:**

With one day left until our live performance, we spend Friday running the show and perform our first dress rehearsal after lunch.

### **SATURDAY (the big day, it's showtime):**

It's the day of the show y'all! 8:45am arrival, and after a final dress rehearsal we'll show off our opening night style on the red carpet and get excited for our first audience. Then, we showcase everything we've learned for our family and friends as we put on an 11am show! The showcase will be followed by a short reception.

  - Any act of vandalism, destruction of property or misuse of facilities.
  - Parents will be liable for payment to replace or repair damages.

  - Illegal drugs and all weapons are strictly prohibited.
  - Theft or activities that endanger the health and safety of you or others are not allowed.

- o Dismissal from Camp at Parents expense. No refunds will be made.
